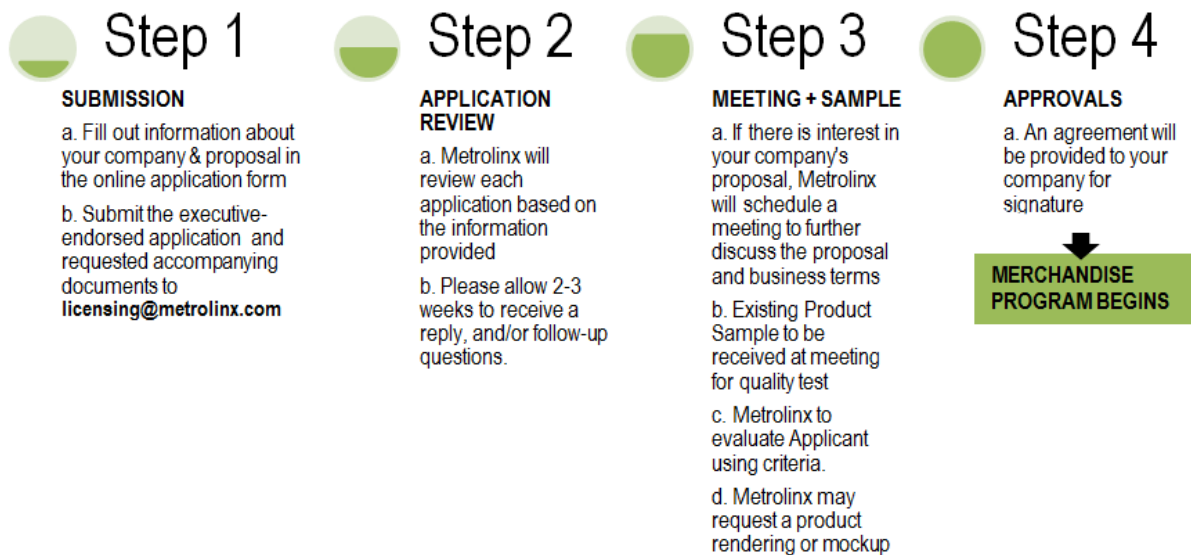




## LICENSEE APPLICATION PROCESS OVERVIEW

Metrolinx has provided an Official Licensed Portal for prospective licensees to submit pre-qualification information and forms. This portal is **ONLY** for companies that are interested in having Metrolinx consider their unsolicited proposals for the licensing of Metrolinx trademarks.

## REQUIRED SUBMISSION ATTACHMENTS

Prospective licensees must also submit the following with their application:

1. A copy of the company's most recent Equifax Credit Report
2. A copy of the commercial general liability insurance certificate
3. A copy of signed Schedule 'C'
4. Reference Check
5. Meet the Minimum Requirements outlined below

Metrolinx may request a product sample similar to the proposed product upon receipt of this application and prior to a meeting between Metrolinx and the Applicant. Metrolinx may also request further clarification or information in relation to the License Application at any time.

## OPTIONAL SUBMISSION ATTACHMENTS

Prospective licensees may also submit the following with their application to help Metrolinx evaluate your license request:

1. Catalogs, brochures and promotional items that display your company's products;

2. Materials or drafts showing how your company proposes to use the Metrolinx marks on products;
3. Full listing of manufacturers
4. Sales and Marketing Plan
